DETAILS OF DEMURRAGE AND DESPATCH

At discharging ports demurrage at the rate of 1,500 EUR per day pro rata to be paid by Buyer.

Total discharging time is 3,85 days (WWD & SSHEX) for Krems. If tonnages is increased, total time will be revised according to discharging rates.

Dispatch at the discharging ports is half of the demurrage (Demurrage/Half Despatch).

DETAILS OF LOADING

Big bags must be stored maximum 8 tiers.

The palletized products should be loaded in 4 tiers maximum and slings shall be applied. Slings must be securely fastened to the top of the pallets.
