

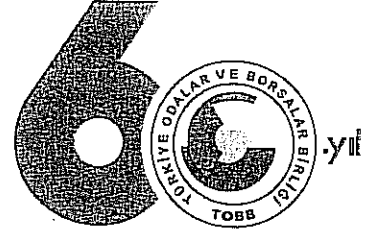

GENERAL CONDITIONS

TERMS OF PAYMENT

Pursuant to the application/contract the payment shall be effected by the "Exhibitor" on the terms of 100 % advance payment to the settlement account specified by the Chamber of Commerce and Industry (CCI) of Turkmenistan (hereinafter referred to as the "Organizer"). After the advance payment made the "Exhibitor" is admitted to the territory of the exhibition in view of installation of exposition. Payment of commission expenses of banks and banks-correspondents for transfer of payment is completely borne by the "Exhibitor".

REGISTRATION OF OFFICIAL VISA SUPPORT

The "Organizer" renders to the "Exhibitor" assistance in getting visa support. Till September 1st, 2012 the "Exhibitor" submits to the "Organizer" a list of persons in accordance with set form with personal passport data.

REDUCTION OF THE RENTED AREA

At reduction of the exhibition area declared in less than 15 days term prior to the beginning of the exhibition the "Exhibitor" pays 100 % cost of not used area.

DELIVERY OF EXHIBITS, CUSTOMS CLEARANCE

The addressee of getting exhibits to the exhibition held is the Chamber of Commerce and Industry (CCI) of Turkmenistan located at the following address: 17, B. Karriyev Str., Ashkhabad, 744004, Turkmenistan; contact phone No.: + (99312) 94 05 49, fax No.: + (99312) 94 13 81. The exhibits imported (exported) to/from the territory of Turkmenistan shall pass customs clearance without fail. The territory of the exhibition centre (exhibition hall) during the exhibition is the customs area. The "Exhibitor" informs the "Organizer" in writing about kind of transportation of exhibits (by air, cargo, by rail, usual, express etc.). Period of storage of exhibits in the warehouse shall not exceed 5 (five) working days from the date of closing of the exhibition. All expenses related to the customs clearance of exhibition cargo are paid by the "Exhibitor" separately against the invoices issued by the "Organizer".

RESPONSIBILITY OF THE PARTIES

The "Exhibitor" is obliged to finish full execution of the exhibition stand one day prior to exhibition opening, not later than 18.00 local time; in case of infringement of the given condition the "Organizer" has the right not to admit him to participate in the work of the exhibition, thus the funds transferred for participation are not repaid.

The "Organizer" undertakes to fulfill his duties on rendering the services included in the cost of participation, to carry out work on attraction of new visitors, experts and commercial agents to the exhibition.

The "Exhibitor" bears property accountability for damage of the exhibition equipment and property to the "Organizer" and pays its overall cost. The "Exhibitor" bears responsibility for observance of rules of fire-prevention and safety precautions, and sanitary code. In case of infringement of the same the "Exhibitor" pays all penal sanctions applied by corresponding control authorities. The "Exhibitor" has got no right to carry out activity which is forbidden while operating time of the exhibition or contradicts the current legislation of Turkmenistan and does not meet its purposes and targets.

FORCE-MAJEURE CIRCUMSTANCES

The "Organizer" does not bear responsibility for occurrence of the force-majeure circumstances complicating or breaking the execution of the exhibition. In this case the "Organizer" reserves the right to fix a different date for exhibition either to postpone it or locate it at the other place. Having recognized that the "Organizer" suffered a considerable damage as a result of the aforesaid as well the "Exhibitor" refuses the indemnification.

SETTLEMENT OF DISPUTES

Disputes and disagreements between the "Exhibitor" and "Organizer" are resolved by negotiations, and in case of failure to achieve the consent they are transferred by the interested Party to the Arbitration Court of Turkmenistan the decisions of which are obligatory and final.

FINAL PROVISIONS

Any changes and additions to the application/contract shall be made in writing. Application/contract filled in duplicate comes into force from the moment of its signing and valid till the full performance of the related obligations by the Parties.

Upon the expiration of validity of the application/contract the Parties if required exchange original documents of the certificates of works (services) acceptance.
